# **ATTORNEY-GENERAL'S PORTFOLIO OVERVIEW**

## **Minister and portfolio responsibilities**

The Attorney-General's Department supports the Attorney-General, the Hon Christian Porter MP, as First Law Officer.

The portfolio comprises the Attorney-General's Department and 13 portfolio agencies.

The portfolio's responsibilities are diverse. They encompass civil justice, criminal justice and national security, legal services, integrity and oversight, courts and tribunals, human rights, privacy, information access, government records management and support for Royal Commissions.

Figure 1 sets out the structure of the portfolio and the outcome statements for each entity.

In the 2019-20 Budget, the Government has made a funding provision of \$104.5 million over four years to establish a Commonwealth Integrity Commission pending the passage of legislation.
